Section 4. First Aid Measures

Routes of Exposure:

If in Eyes	Rinse cautiously with water for 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice.
If on Skin	Wash with plenty of soap and water. If skin irritation or rash occurs: get medical advice/attention. Take off contaminated clothing and wash before reuse.
If Swallowed	Do not induce vomiting. Wash out mouth thoroughly with water. Never give anything to the mouth of an unconscious person. If vomiting occurs, place victim face downwards, with the head turned to the side and lower

than the hips to prevent vomit entering the lungs. Seek medical attention if needed.

Section 6. Accidental Release Measures

Wear protective gear as detailed in Section 8. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. Evacuate all unnecessary personnel.

Do not allow to enter drains and water courses.
